**No.AR-5/ASSO/98 (Pt-II) :** : In the interest of public service and with a view to ensure that the full complement of medical personnel under the Health & Family Welfare Department is in hand to effectively tackle the present pandemic-menace of COVID-19 in the State, the Governor of Nagaland is pleased to extend the services of the following medical staff, who may have proceeded on retirement effective 31-3-2020 but are willing to continue in service, for a period of 03 (three) months with effect from **01-04-2020 to 30-6-2020**.

- (i) Doctors
- (ii) Nurses
- (iii) Technicians
- (iv) Para-medics

2. The service-extension of 03 (three) months is subject to the following terms and conditions.
- a/ The medical staff concerned shall be paid the pay & allowances equivalent to the salary last drawn as on 31-3-2020, for service rendered against each of the extended 03 (three) months' period.
  - b/ The period of the 03 (three) months extended service, however, shall not be computed as qualifying-service for the purpose of pension.
  - c/ The tenure of the extended 03 (three) months' service shall be reviewed as deemed fit depending upon the prevailing situation.
3. This is issued in relaxation of Office Memorandum No. AR-5/ASSO/98 dated 15-3-2012 and in pursuance of the Cabinet's decision conveyed vide Memorandum No. CAB-2/2013 dated 31-3-2020.
