## **CIRCULAR**

No.AR-3/GEN-9/97 (Pt):: In continuation of this Department's circular number of even number dated 29th August, 2019, all the Departments are reminded again to identify post which can be reserved for Persons with Disabilities which is as per the Rights of Persons with Disabilities Act, 2016. The AHODs are requested to personally monitor the assigned work to identify posts to be reserved for the persons with benchmark disabilities (both Gazetted & Non-Gazetted Group A,B,C and D) within their respective Department/Directorate . The Departments may utilize the Notification No.16-15/2010-DD-III dated 29th July 2013 issued by the Department of empowerment of Persons with Disabilities, Ministry of Social Justice & Empowerment, Government of India as a reference material while identifying various categories of posts to be reserved for persons with Disabilities under their Department. All the Departments are directed to complete the exercise and re-submit the information latest by 8th November, 2019 as the proposal received from most of the Departments are not comprehensive and only contains non-gazetted posts and some Departments have submitted 'nil' report. It is also regretted that out of 69 Departments, only 29 Departments have submitted the proposal so far. Hence all the AHODs are requested to re-submit the consolidated revised proposal in line with the above directives as mentioned in Para 1. Failure to submit the identified posts will give full privilege to the Expert Committee to include any post to be reserved on their own volition and hence, no representation will be entertained afterwards.
