NO.HOME/LOANN/MISC/7-4/85-86; In supersession of this Departments Notification of even number dated 24-11-94, the Governor of Nagaland is pleased to revise the terms and conditions for grant of motor conveyance advance to the government servants as follows in amendment to Rules 193,199,201 and 211 of the General Financial Rules, 1963 with immediate effect.

1. Motor Car advance.

- (a) <u>Eligibility</u>: Employees drawing pay including special increment non-practicing allowances of Rs. 10,500/- P.M. or more are eligible (Photostat copy of the last pay slip should invariably be enclosed with the application as a proof)
- (b) Amount of advance:-
 - (i) On first occasion Rs.1,80,000 or eleven months basic pay +SI+NPA or anticipated price of car, whichever is the least.
 - (ii) On second and subsequent occasions Rs.1,60,000 or eleven months basic pay +SI+NPA or price 3 of car, whichever is the least.

(c) Other conditions

- (i) A second advance can be taken for purchase of a different make of car without selling previous one purchased with advance, but outstanding advance and interest must be repaid before grant of second/subsequent advance.
- (ii) Second and subsequent advance may be given only after 4 years from the date of drawal of perilous advance.
- (iv) Recovery of advance will be made in maximum 200 monthly installments. Employees can pay more than one instalments in a month.
- (v) Recovery of the advance will start from first pay after drawal of advance.

(d) Interest on the advance.

The rate of interest on Motor Car advance will be 15% (fifteen percent) per annum and shall be recoverable in the minimum number of monthly instalment. The amount of each instalment shall not be less than the amount of instalment for recovery of advance. The recovery of interest shall commence from the month immediately following that in which the repayment of the advance principal is completed.

2. Motor cycle/advance

(a) <u>Eligibility</u>: - Employees drawing pay (basic pay-131 + NPA) OF Rs. 4,600.P.m. or more are legible (A certificate from the Head of the Department to the effect that the basic pay indicated in the application is true and correct should invariable be furnished alongwith the application)

(b) Amount of advance:-

- (i) On first occasion Rs 30,000 or 6 months pay or anticipated price of Motor Cycle/Scooter, whichever is the least.
- (ii) On second and subsequent occasion Rs.24, 000 or 5 months pay or anticipated price of Motor Cycle/Scooter, whichever is the least.

(c) Other conditions:-

Other conditions are same as in case of Motor Car advance except that the recovery will be made in maximum 70 monthly instillments.

(d) Rate of Interest

The rate of interest on Motor cycle/scooter advance will be 11½ (eleven and half percent) per annum. The rate and mode of recovery are same as in case of Motor Car advance.

- 3. Permanent Govt. servants should furnish an attested copy of confirmation order along with the application.
- 4. Temporary Govt. servants may also apply for the advance by furnishing a "Surety Bond" in form G.F.R. 21 from a permanent Govt. Servant of same status or above, but an attested copy of the confirmation order of the Govt. servant who stands for Surety should be furnished along with the Bond.
- 5. The Heads of Departments while recommending cases for Motor conveyance advance should verify the basic pay, length of service, date of birth and other particulars of the applicant(s) as furnished in the application are correct as per official records. Further, a certificate to the effect that possession of a Car/Scooter etc. by the officials is in the interest of public service has to be furnished.
- 6. The application which does not fulfill all the conditions mentioned above shall be summarily rejected and no further correspondence in this respect will be entertained.
- 7. Application for Motor conveyance shall remain valid for 3(three) years from the date of receipt in the Department. Any application not considered within the validity period will automatically become invalid and the applicant has to submit fresh application if he/she is still desirous of availing the advance.
- 8. This issues will the approval and concurrence of Finance Department vide their No.RFC/ESTT/No.26/58 dated 15-05-2001.

D. **An excess Vehicles/ Drivers:**

- After determining and earmarking vehicle in the Directorates on the ration of 5.1, excess vehicles and Drivers if any will be utilized as under:
- (i) Field officers in the department entitled to but without attached vehicles will be allotted the vehicles as per their entitlement along with the drivers.
- Further excess vehicles if any will be deposited with the Transport and Communication (ii) Department for filling essential gaps in other departments running short of vehicle or for disposal at depreciated/reserved price.
- Further excess drivers if any will be placed at the disposal of Transport and (iii) Communication department
 - Those excess drivers on casual basis will be terminated from their appointments.
 - Those excess drivers on regular post will be given to Departments running short of (b) drivers along with the posts.

Ε. **Repair/maintenance Entitlements.**

With the exception of vehicles attached to the Chief Secretary, Maintenance/repair of 1. attached vehicles will be the personal responsibility of the user official as per the under mentioned entitlements:

- * In view of the enhanced block year repair, cost entitlement, every attached vehicle is expected to be maintained properly and no major repair will be done by the department separately for the attached vehicles under any circumstances.
- 2. Pool duty vehicle only will continue to be repaired/maintained by the concerned Department.
- 3. While attaching a vehicle to an official, the department is expected to hand over the vehicle in good running condition. Thereafter, maintenance/repair of the vehicle becomes the individual official's responsibility within the vehicle's Block Year maintenance fund.

F. POL entitlements for attached vehicles.

Considering the frequency of longer or shorter trips required to be made at the stations, the following POL entitlements are prescribed for station duty.

4. All others including duty vehicles when used for govt. station duty: 50 litres p.m. No empty run re-imbursed to be allowed.

G. Vehicle Condemnation criteria.

In addition to following the existing procedure, as vehicle must fulfill the following minimum conditions for condemnation:

(i) Age -Minimum 8 years (ii) Mileage run -Minimum 1.50 lacs.

(iii) Repair cost - No bar

(iv) Vetting - Nodal Dept's (TPT) concurrence

(v) Disposal value -17th of Book value.

II. <u>Certain facilities are given to</u>:

- (i) Deputy Secretary and above and other Class-I: Purchase of one condemned vehicle in one's officers with minimum 25 years of service life at 1/7th of book value reserved price from any Department, if available.
- (ii) For Class- I Junior and above officers: Bank loan facility for purchase of vehicle, with Government guarantee, monthly repayment deduction from pay at source terms and conditions to be worked out by Finance Department, and government to take up with Bank for a policy arrangement.
- (iii) Motor vehicle Advance @ 75% of vehicle values to be revived for Government servants if state resources permit- Finance Department to work out details.
- (iv) Improvement of Secretariat Bus service and arrangement of deluxe for commuting officers on payment of fare- Home Department and Transport & Communication Department to follow-up.

- (v) Conveyance Allowance-Status quo to be maintained @ Rs 300/- P.M for Deputy/Under Secretaries.
- (vi) Government Buses/trucks to be completely banned for any private use, except on payment of prescribed hire charges to be deposited in advance.
- (vii) Children/unauthorized persons to be prohibited to drive Government vehicle is attached or detailed.
- (viii) Accident repair cost as a result of unauthorized driving will be borne by the concerned officer to whom the vehicle is attached or detailed.

4. <u>Vehicle Entitlements:</u>

While phasing out or replacing the existing vehicles on their condemnation, entitlement to vehicles will be as follows: -

- 1. Secretaries/Directors and above
- 2. Addl. Secretaries/Joint Secretaries/ Staff duty vehicles
- 3. Field officers

- Esteem/Gypsy/Bolero/A.Car.
- Maruti Van/A/Car.
- Gypsy soft Top Mahindra Jeep MM 540 Soft Top (Diesel).

J. Nodal Department's Role:

Besides other required conditions and procedures,

- 1. Purchase of new vehicle as well as condemnation of old ones will require Transport & Communication Department's concurrence,
- 2. Purchase of vehicles even under C.S.S. and projects may only be allowed after Planning clearance/ Finance & TPT concurrence with full justification.
- 3. Allotment of condemned vehicles will be done by Transport & Communication Department on completion of all other conditions.
- 4. Without proof of the above orders, registration of Government vehicles in private name will not be allowed by Transport Commissioner.

This order shall take effect from 1-4-2003.

OFFICE MEMORANDUM

No.TPT/SPL/14/89. The Civil Secretariat Transport Pool is required to cater to various transport requirements in the government Civil Secretariat establishment such as attachment of vehicle to the Hon'ble Chief Minister and his Ministerial Colleagues, Senior Officers in the Civil Secretariat establishment, State guests and other VIP legitimate duties. At any given point of time, the pressure for vehicle requirement is always very heavy, on many occasions much more than the total number of vehicles available with the Pool, since many of the vehicles require to be immobilized temporarily in the workshop for repair and maintenance works.

- 2. On various occasions when the requirement of vehicles for performance of various government duties exceeds the number of vehicles actually available with the Transport Pool, the department is compelled to requisition and withdraw government vehicles from various Senior Officers and Department for temporary use.
- 2. It has been observed and noted rather painfully that on many occasions the Officers and Staff of the Civil Secretariat Transport Pool are being harassed and verbally abused, sometimes even threatened physically when they are unable to comply with requests received from various quarters for attachment or detailment of vehicles for no fault of theirs. Obviously, those Officers are not in a position to give or detail vehicles which the Secretariat Transport Pool does not possess and extraordinary efforts are generally involved when demands are placed before them during off duty hours with little or no space available for making eleventh hour extra transport arrangements.
- 3. It has been also noted on certain occasions that vehicles of the Transport pool being repaired in the workshops and earmarked specifically either for certain Hon'ble Ministers or officers or for some other VIP duties are being forcibly taken away, thereby creating totally unnecessary and avoidable difficulties to the department, as well as generating bad feelings that are quite unnecessary.
- 4. From time to time, requests are also being received from Hon'ble MLAs for detailment of vehicle from the Civil Secretariat pool for performance of duty during their Assembly constituency tours or other Assembly Committee tours. There seems to be no government order which makes it obligatory on the part of the Civil Secretariat Transport Pool to provide vehicles to the Hon'ble MLAs as a matter of duty and obligation We do indeed expect that requirements of extra transport of Hon'ble MLAs as and when needed would perhaps be arranged by the Assembly Secretariat and that when on certain occasions the Civil Secretariat Transport Pool is a position to help the Hon'ble MLAs for specific duties and specific periods of time, it should be considered more as a courtesy gesture.
- 5. In view of the recurring reported occasions in which the Officers and Staff of the Civil Secretariat Transport Pool have been verbally abused and unduly harassed on account of circumstances often beyond their immediate control, this department is constrained to issue this Office Memorandum to highlight on the one hand the constraints and difficulties under which the Transport Pool officers try their best to fulfill various legitimate demands for Government duties

and on the other hand the need for maintaining certain courteous attitude and behaviour towards the Pool officers when they are not at fault.

6. This is to also clarify that for VIPs on visit to the State who are declared as State Guests, it is the responsibility of the Civil Secretariat Transport Pool to arrange transport. However, for various programmes and activities organized by the departments, they are expected to arrange transport, when the need arises, for their resource persons coming from outside unless such resource persons are also declared as State Guests by the Home department. A VIP Special Pool comprising a very small fleet of vehicles is being maintained by the Department meant exclusively for those declared as State Guests by the Home Department.

- 5. All taxis shall also paint on both sides of the front door the particulars specified in Annexure-A appended to this notification.
- 6. All stage/contract carriage buses shall display on a board placed above or on top of the windshield the name of the route for which a permit is granted.

7. This notification shall come into immediate effect for all new taxis and buses and with effect from 1st October 2003 in respect of existing taxis and buses, read with this Department Notification of even number dated 13th November 1995 in respect of local taxis.

NOTIFICATION

In order to streamline the process of allotment of condemned Vehicle/Machineries under all Government Departments, it has been decided that the following guidelines shall henceforth observed under the State of Nagaland.

- 1. Allotment of all condemned Vehicles shall be provisionally allotted to the allotee by the Transport Department.
- 2. Once the provisional allotment order is issued, the allotees shall deposit the prescribed value made by the respective Department through Treasury Challan.
- 3. Reserved price/ Depreciated value of the condemned vehicle is to be deposited into the Government account and a copy of the Treasury Challan indicating Challan number and date is prescribed within 30 (Thirty) days from the date of issue of the Provisional Allotment Order, failing which the Provisional allotment order will be cancelled and shall be allotted to other applicants.
- 4. Final allotment Order/Clearance for recovering to Private Registration shall be issued by the Transport Department after the production of the Treasury Challan.
- 5. Vehicles disposed on scrap rate will not be allowed for Re-registration.
