**OFFICE MEMORANDUM**

**Subject: PARTIAL LIFTING OF APPOINTMENTS.**

In pursuance of the Cabinet decision conveyed vide No.CAB-2/2013(Pt) dated 14<sup>th</sup> July, 2021, the Governor of Nagaland is pleased to allow partial lifting of ban on appointments against existing vacancies with the following conditions: -

- (i) Allow 10 Departments listed in Category-A, to complete the recruitment process with respect to the total of 160 various posts as per Annexure-I.
  - (ii) To relax and permit the 66 Departments listed in Category-B, for recruitment of a total number of 1357 various posts. Lists of Category-B shall be intimated individually to each respective department.
  - (iii) To follow the existing policy of recruitment for reservation under BT/PWD through open advertisement by NPSC/DRB/DLRB.
2. The concerned Departments shall carry out the recruitments by the NPSC and the respective Departmental Recruitment Board (DRB) (for posts outside the purview of the NPSC) as an exception, till such time the Nagaland Staff Selection Board (NSSB) is made functional. Further, all Group-D posts shall be filled up by the respective inhabitants of the districts except for Group-D posts under the Secretariat and Directorate offices, as per rules in force.
3. There shall be relaxation of age for entry into government service for a period of 1 (one) year with effect from 22<sup>nd</sup> April, 2020.
