**C I R C U L A R**

**No. AR-3/Gen-9/97 (VOL-I):** This is to inform that with the enactment of the Rights of Persons with Disability Act, 2016 and subsequent P&AR Notification No. AR-3/Gen-9/97, dt. 13.08.2020 on reservation of posts for Persons with Benchmark Disability (PwBD), the roster for reservations of posts for PwBD will henceforth be maintained by respective departments as per Section-8 of the Notification.

2. The Departments are directed to observe the certification process in section-18 of the rules during the requisition of posts to NPSC, NSSB and DRB. Departments may note section-19 of the rules where by an annual compliance report is to be submitted on the 1<sup>st</sup> of April of each year.

3. The Departments at Annexure-I, which have already requisitioned posts to NPSC which were advertised vide NPSC Notification No. NPSC/ADVT/NON-TECH/8/2018, dt. 14.10.2019 are instructed to submit the PwBD reservation list/roster points of their respective Departments against the posts requisitioned, at the earliest to the NPSC.

**No.AR-3/GEN-9/97 (Pt) ::** In pursuance of Section 22 of The Rights of Persons with Disabilities Act, 2016 all the Administrative Head of Departments/Head of Departments are requested to comply with the provision of the section which is reproduced below as follows :-

*"Section 22. (1) Every establishment shall maintain records of the persons with disabilities in relation to the matter of employment, facilities provided and other necessary information in compliance with the provisions of this Chapter in such form and manner as may be prescribed by the Central Government.*

*(2) Every employment exchange shall maintain records of persons with disabilities seeking employment.*

*(3) The records maintained under sub-section (1) shall be open to inspection at all reasonable hours by such persons as may be authorised in their behalf by the appropriate Government."*
